1 COMES NOW, *PERLINE THOMPSON, LISA GEORGE, ALFREDA WALKER,*
2 *JACQUELINE HODSON, LORIN WATSON, BOYD GRAHAM AND GONNIE MENDEZ, and*
3 *DOES I-X*, hereinafter to be referred to collectively as “Plaintiffs,” unless identified specifically
4 as individuals, does hereby submit their MOTION ALTER OR AMEND THE COURT’S
5 ORDER OF SEPTEMBER 25, 2018, and does set forth the following POINTS &
6 AUTHORITIES IN SUPPORT their Motion to wit:

8 **POINTS & AUTHORITIES**

9 Pursuant to *Federal Local Rule 59-1 Motions for Reconsideration of Interlocutory*
10 *Orders and Federal Rules of Civil Procedure 59 and 60*, of which govern the rules relative to
11 requesting the court to reconsider and or alter or amend its orders. As this motion is filed within
12 10 day s of judgement, the dismissal without prejudice order, the motion should be treated as a
13 motion to alter or amend. *Bass v. United States Department of Agriculture, 211 F.3d 959, 962*
14 *(5th Cir. 1998)* *Edward H. Bohlin Co. v. Banning Co., 6 F3d. 350, 353 (5th Cir. 1993)* (citing
15 *Lavespoere v. Niagara Mach. & Took Works Inc., 910 F2d 167, 173 (5th Cir. 1990)*). Case law
16 dictates that of the criteria under *Rule 59(e)*, for the court’s dismissal action, that Plaintiffs cite
17 (3) to prevent manifest injustice. The manifest injustice in this matter is that the Plaintiffs stand
18 to lose their right to seek the court’s order to require the Defendants to allow for appellate
19 process in the Intertribal Court of Appeals on their case originating from the Duckwater
20 Shoshone Indian Tribal Court, Duckwater, Nevada.

21 That under *Rule 60*, the court has the authority to relive a party from the effects of the
22 dismissal order for mistake...excusable neglect and any other reason justifying relief from the
23 judgement.” The Plaintiffs have the burden to set forth as to why their circumstance in included
24 in the justifications for relief under *Rule 60*.

25 **FACTS T**

26 hat on the 27th day of September 2018, Plaintiffs received via U.S. Mail, from

1 the Court, the document entitled ORDER OF DISMISSAL WITHOUT PREJUDICE
2 PURSUANT TO FRCP 4(m).

3 Immediately, Plaintiffs communicated with one another regarding the dismissal and
4 recognized that they had indeed completed service of the above-named Defendants, with the
5 exception of one, Mitchell Wright.

6 As pro per Plaintiffs, relying only on non-attorney assistance, had not, nor had the
7 intention of, ignoring the requirements of filing the proof of service with the court, nor had the
8 Plaintiffs been sent a Notice of Intent to Dismiss, ECF No. 19. It is now evident to the Plaintiffs
9 that they must obtain proper legal counsel. That it was a mistake in the understanding of the
10 court's processes and not an intentional disregard for the processes.

SUMMATION

That missing the requirement to file the proof of service of the Defendants was not meant to circumvent or intentionally affect the case negatively and this motion to reconsider the Court's order of September 25, 2018 is submitted in good faith. That by a showing that the Plaintiffs are addressing their deficit immediately, it is evident that not filing the proofs of service was an oversight and that the Plaintiffs did not intend to ditch their lawsuit or cause the Court to enter the order of dismissal.

Further, that through the submission of this motion, the Plaintiffs seek, in good faith, to adhere to all future requirements of the court through the recognition of the rules of Court.


That the Plaintiffs are suing to uphold the integrity of their right to be heard at the appellate court, as so designated by their Duckwater Shoshone Tribal Law and Order Code and are not seeking any monetary compensation through their civil suit. The issue is of great importance and affects not only the Duckwater, but other tribes in Northern Nevada.

That the Plaintiffs contend that reconsidering the order of September 25, 2018 would not cause detriment to any of the Defendants, other than holding them accountable in their capacities to ensure that cases can move forward for Tribes, without fail, in the Intertribal Court of Appeals, as administered by the United States and the agencies and people under their watch.

Prayer for Relief

WHEREFORE, Plaintiff prays that the Court ALTER OR AMEND ITS ORDER of September 25, 2018 and allow the case to move forward toward hearing and time to respond to any and all motions/notices, as so required.

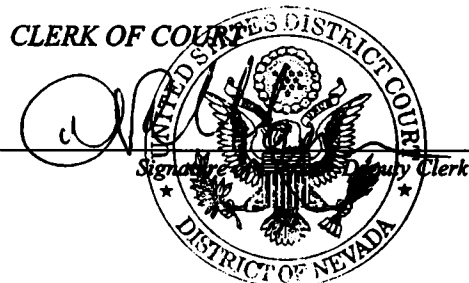

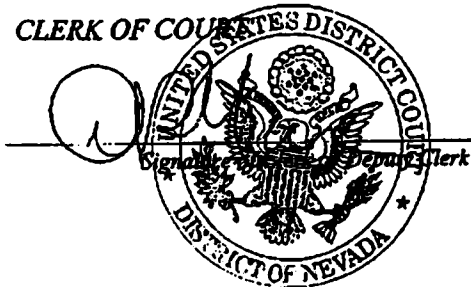
