MOTION TO ORDER THE UNITED STATES OF AMERICA TO  
FILE A RESPONSIVE PLEADING TO APPLICATION FOR RELIEF  
FROM ORDER AND JUDGMENT

Lindsey K. Springer ("Springer") moves this Court for an order directing the United States of America to file a responsive pleading to Springer's Application for Relief from the Order (Doc. 179) and Judgment (Doc. 180) filed simultaneously herewith.


Local Rules for the Northern District of Oklahoma, Rule 7.2(e), provides that a responsive pleading be filed within 21 days from the filing date of a dispositive pleading and that when unopposed the Court may deem the dispositive pleading confessed under Rule 7.2(f).

Springer requests the District Court allow a record to be made by the United States of America where the ground raised in Springer's Application filed simultaneously herewith shows the United States Judicial District for the Northern District of Oklahoma and its Article III, § 1 District Court, lacked Article III Judicial Power and Jurisdiction, lacked statutory subject matter jurisdiction, and lacked an Article III, § 2 live case or controversy as of May 9, 2008, when the complaint was filed beginning this proceeding, and as of October 10, 2008, when the amended complaint was filed.

Springer has no way of knowing whether the United States of America would oppose this Motion.


