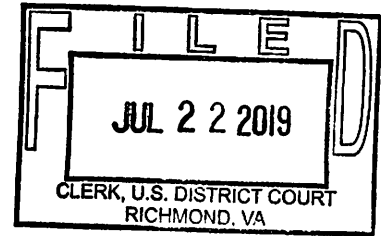

**ORDER**

Having considered the decision of the United States Court of Appeals for the Fourth Circuit in Williams, et al. v. Big Picture Loans, LLC, et al., No. 18-1827, 2019 WL 2864341 (4th Cir. July 3, 2019) (the "Fourth Circuit's Decision"), and mindful that there are pending in this Court numerous motions both in this case and in miscellaneous cases that are related to this case ("related miscellaneous cases"), it is hereby ORDERED that:

(1) By August 23, 2019, the parties to this case, other than Lula A. Williams, et al., shall file a Statement of Position ("SOP"), or, if appropriate, a motion, setting out their positions on: (a) the effect, if any, of the Fourth Circuit's Decision on further proceedings in this case; and (b) the effect, if any, of the Fourth Circuit's Decision on each pending motion in this case, as it pertains to the party filing the SOP or motion; and

(2) By September 16, 2019, Lula Williams, et al., shall file responses to those SOP's or motions; and replies shall be filed by September 23, 2019.

It is further ORDERED that:

(3) By August 23, 2019, the parties to the related miscellaneous cases, other than Lula Williams, et al., shall file a SOP or, if appropriate, a motion, on the effect of the Fourth Circuit's Decision on the pending motion(s) in the related miscellaneous cases; and

(4) By September 16, 2019, Lula Williams, et al., shall file responses to those SOP's or motions; and replies shall be filed by September 23, 2019.

If, before August 16, 2019, a petition for rehearing or rehearing *en banc* of the Fourth Circuit's Decision shall have been filed, the due date for SOP's or motions shall be fourteen (14) days after a decision by the United States Court of Appeals for the Fourth Circuit on such petition unless, by subsequent Order, the Court directs otherwise. Response briefs and reply briefs shall be on the same time sequences outlined in paragraphs (2) and (4) above.

The Clerk is directed to file a copy of this ORDER in Galloway v. Williams, et al., Misc. No. 3:19mc9; Williams, et al. v. Microbilt Corporation, Misc. No. 3:19mc14; and Weddle v. Williams, et al., Misc. No. 3:19mc15.

It is so ORDERED.
