Consolidated Plaintiff the Modoc Nation, by and through undersigned counsel, hereby gives notice that it is voluntarily dismissing all of its claims against Defendants Gentner Drummond and Douglas Pewitt pending in the above captioned litigation, without prejudice, pursuant to Fed. R. Civ. P. 41(a)(1)(A)(i) and LCvR41-1.

Plaintiff Modoc Nation states that it has not previously dismissed any federal or state court suits based on or including the same claims. The Modoc Nation additionally states that Defendants have not filed an answer or a motion for summary judgment, and Defendants consent to this dismissal.
